Safety, performance, and dependability have been given top priority in the design of your rotary hammer drill.

INTENDED USE

This rotary hammer drill is intended to be used only by adults who have read and understood the instructions and warnings in this manual and can be considered responsible for their actions. It is to be used by a single operator by grasping both trigger and side handles.

The rotary hammer drill is designed to operate without hammer function into wood and metal. For chiselling and masonry drilling, the hammer mode may be used.

The rotary hammer drill is designed to operate with drill bits up to the maximum diameter defined in the product specification table.

Do not use the product in any way other than those stated for intended use.

GENERAL POWER TOOL SAFETY WARNINGS

A WARNING

Read all safety warnings and all instructions. Failure to follow the warnings and instructions may result in electric shock, fire and/or serious injury.

Save all warnings and instructions for future reference.

The term "power tool" in the warnings refers to your mains-operated (corded) power tool or battery-operated (cordless) power tool.

1) WORK AREA SAFETY

- a) Keep work area clean and well lit. Cluttered or dark areas invite accidents.
- b) Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Power tools create sparks which may ignite the dust or fumes.
- Keep children and bystanders away while operating a power tool. Distractions can cause you to lose control.

2) ELECTRICAL SAFETY

- a) Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) power tools. Unmodified plugs and matching outlets will reduce risk of electric shock.
- Avoid body contact with earthed or grounded surfaces, such as pipes, radiators, ranges and refrigerators. There is an increased risk of electric shock if your body is earthed or grounded.
- c) Do not expose power tools to rain or wet conditions. Water entering a power tool will increase the risk of electric shock.
- d) Do not abuse the cord. Never use the cord for carrying, pulling or unplugging the power tool. Keep cord away from heat, oil, sharp edges or moving parts. Damaged or entangled cords increase the risk of electric shock.

- When operating a power tool outdoors, use an extension cord suitable for outdoor use. Use of a cord suitable for outdoor use reduces the risk of electric shock
- f) If operating a power tool in a damp location is unavoidable, use a residual current device (RCD) protected supply. Use of an RCD reduces the risk of electric shock.

3) PERSONAL SAFETY

- a) Stay alert, watch what you are doing and use common sense when operating a power tool. Do not use a power tool while you are tired or under the influence of drugs, alcohol or medication. A moment of inattention while operating power tools may result in serious personal injury.
- b) Use personal protective equipment. Always wear eye protection. Protective equipment such as dust mask, non-skid safety shoes, hard hat or hearing protection used for appropriate conditions will reduce personal injuries.
- c) Prevent unintentional starting. Ensure the switch is in the off-position before connecting to power source and/or battery pack, picking up or carrying the tool. Carrying power tools with your finger on the switch or energising power tools that have the switch on invites accidents.
- d) Remove any adjusting key or wrench before turning the power tool on. A wrench or a key left attached to a rotating part of the power tool may result in personal injury.
- Do not overreach. Keep proper footing and balance at all times. This enables better control of the power tool in unexpected situations.
- f) Dress properly. Do not wear loose clothing or jewellery. Keep your hair, clothing and gloves away from moving parts. Loose clothes, jewellery or long hair can be caught in moving parts.
- g) If devices are provided for the connection of dust extraction and collection facilities, ensure these are connected and properly used. Use of dust collection can reduce dust-related hazards.

4) POWER TOOL USE AND CARE

- a) Do not force the power tool. Use the correct power tool for your application. The correct power tool will do the job better and safer at the rate for which it was designed.
- b) Do not use the power tool if the switch does not turn it on and off. Any power tool that cannot be controlled with the switch is dangerous and must be repaired.
- c) Disconnect the plug from the power source and/or the battery pack from the power tool before making any adjustments, changing accessories or storing power tools. Such preventive safety measures reduce the risk of starting the power tool accidentally.
- d) Store idle power tools out of the reach of children and do not allow persons unfamiliar





with the power tool or these instructions to operate the power tool. Power tools are dangerous in the hands of untrained users.

- e) Maintain power tools. Check for misalignment or binding of moving parts, breakage of parts and any other condition that may affect the power tool's operation. If damaged, have the power tool repaired before use. Many accidents are caused by poorly maintained power tools.
- f) Keep cutting tools sharp and clean. Properly maintained cutting tools with sharp cutting edges are less likely to bind and are easier to control.
- g) Use the power tool, accessories and tool bits etc, in accordance with these instructions, taking into account the working conditions and the work to be performed. Use of the power tool for operations different from those intended could result in a hazardous situation.

5) SERVICE

Have your power tool serviced by a qualified repair person using only identical manufacturer's replacement parts. This will ensure that the safety of the power tool is maintained.

HAMMER SAFETY WARNINGS

- Wear ear protectors. Exposure to noise can cause hearing loss.
- Use auxiliary handle(s), if supplied with the tool. Loss of control can cause personal injury.
- Hold power tool by insulated gripping surfaces, when performing an operation where the cutting accessory may contact hidden wiring or its own cord. Cutting accessory contacting a "live" wire may make exposed metal parts of the power tool "live" and could give the operator an electric shock.
- Wear safety goggles to protect your eyes from flying particles and splinters.

RESIDUAL RISKS

Even when the rotary hammer drill is used as prescribed, it is still impossible to completely eliminate certain residual risk factors. The following hazards may arise and the operator should pay special attention to avoid the following:

- Risk of electrocution if electric cables are drilled into.
 Always grasp the tool by designated handles, do not touch the drill bits.
- Kick-back whilst drilling if the bit jams. Always use the side handle and grip the tool firmly.
- Damage to the respiratory system. Wear respiratory protection masks containing filters appropriate to the materials being worked. Ensure adequate workplace ventilation. Do not eat, drink or smoke in the work area.
- Damage to hearing. Always wear effective hearing protection and limit exposure to noise.
- Damage to eyes from flying dust and debris particles.
 Always wear suitable eye protection.
- Injury caused by vibration. Hold the tool by designated handles and limit exposure to vibration. See "RISK

REDUCTION".

RISK REDUCTION

It has been reported that vibrations from hand-held tools may contribute to a condition called Raynaud's Syndrome in certain individuals. Symptoms may include tingling, numbness and blanching of the fingers, usually apparent upon exposure to cold. Hereditary factors, exposure to cold and dampness, diet, smoking and work practices are all thought to contribute to the development of these symptoms. There are measures that can be taken by the operator to possibly reduce the effects of vibration:

- Keep your body warm in cold weather. When operating the unit wear gloves to keep the hands and wrists warm. It is reported that cold weather is a major factor contributing to Raynaud's Syndrome.
- After each period of operation, exercise to increase blood circulation.
- Take frequent work breaks. Limit the amount of exposure per day.

If you experience any of the symptoms of this condition, immediately discontinue use and see your doctor about these symptoms.

A WARNING

Injuries may be caused, or aggravated, by prolonged use of a tool. When using any tool for prolonged periods, ensure you take regular breaks.

MAINTENANCE

A WARNING

The product should never be connected to a power supply when you are assembling parts, making adjustments, cleaning, performing maintenance, or when the product is not in use. Disconnecting the product will prevent accidental starting that could cause serious injury.

A WARNING

When servicing use only original manufacturer's replacement parts. Use of any other parts may create a hazard or cause product damage.

 Avoid using solvents when cleaning plastic parts. Most plastics are susceptible to various types of commercial







solvents and may be damaged by their use. Use clean cloths to remove dirt, carbon dust, etc.

A WARNING

Do not at any time let brake fluids, gasoline, petroleumbased products, penetrating oils, etc., come in contact with plastic parts. They contain chemicals that can damage, weaken or destroy plastic.

Electrical tools used on fiberglass material, wallboard, spackling compounds, or plaster are subject to accelerated wear and possible premature failure because the fiberglass chips and grindings are highly abrasive to bearings, brushes, commutators, etc. We do not recommend using the product for extended work on these types of materials.

A WARNING

Always wear safety goggles or safety glasses with side shields during power tool operation or when blowing dust. If operation is dusty, also wear a dust mask.

- If the power supply cord is damaged, it must be replaced only by the manufacturer or by an authorized service center to avoid risk. Contact authorized service center.
- For greater safety and reliability, all repairs should be performed by an authorised Ryobi service centre.

LUBRICATION

All of the bearings in the product are lubricated with a sufficient amount of high grade lubricant for the life span of the product under normal operating conditions. Therefore, no further lubrication is required.

VIBRATION LEVEL



WARNING

The vibration emission level given in this information sheet has been measured in accordance with a standardised test given in EN 60745 and may be used to compare one tool with another. It may be used for a preliminary assessment of exposure. The declared vibration emission level represents the main applications of the tool. However if the tool is used for different applications, with different accessories or poorly maintained, the vibration emission may differ. This may significantly increase the exposure level over the total working period.

An estimation of the level of exposure to vibration should also take into account the times when the tool is switched off or when it is running but not actually doing the job. This may significantly reduce the exposure level over the total working period. Identify additional safety measures to protect the operator from the effects of vibration such as: maintain the tool and the accessories, keep the hands warm, organisation of work patterns.









GUARANTEE

In addition to any statutory rights resulting from the purchase, this product is covered by a guarantee as stated below.

- 1. The guarantee period is 24 months for consumers and commences on the date when the product was purchased. This date has to be documented by an invoice or other proof of purchase. The product is designed and dedicated to consumer and private use only. So there is no quarantee provided in case of professional or commercial use.
- 2. There is, in some cases (i.e. promotion, range of tools), a possibility to extend the warranty period over the period described above using the registration on the www.ryobitools.eu website. The eligibility of the tool is clearly displayed in stores and/or on packaging. The end user needs to register his/her newly-acquired tools online within 8 days from the date of purchase. The end user may register for the extended warranty in his country of residence if listed on the online registration form where this option is valid. Furthermore, end users must give their consent to the storage of the data which are required to enter online and they have to accept the terms and conditions. The registration confirmation receipt, which is sent out by e-mail, and the original invoice showing the date of purchase will serve as proof of the extended warranty. Your statutory rights remain unaffected.
- 3. The guarantee covers all defects of the product during the warranty period due to defaults in workmanship or material at the purchase date. The guarantee is limited to repair and/or replacement and does not include any other obligations including but not limited to incidental or consequential damages. The warranty is not valid if the product has been misused, used contrary to the instruction manual, or being incorrectly connected. This guarantee does not apply to:
 - any damage to the product that is the result of improper maintenance
 - any product that has been altered or modified
 - any product where original identification (trade mark, serial number) markings have been defaced, altered or removed
 - any damage caused by non-observance of the instruction manual
 - any non CE product
 - any product which has been attempted to be repaired by an non-qualified professional or without prior authorization by Techtronic Industries
 - any product connected to improper power supply (amps, voltage, frequency)
 - any product used with inappropriate fuel mixture (fuel, oil, percentage of oil)
 - any damage caused by external influences (chemical, physical, shocks) or foreign substances
 - normal wear and tear of spare parts
 - inappropriate use, overloading of the tool
 - use of non-approved accessories or parts
 - carburettor after 6 months, carburettor adjustments after 6 months
 - components (parts and accessories) subject to natural wear and tear, including but not limited to bump knobs, drive belts, clutch, blades of hedge trimmers or lawn mowers, harness, cable throttle, carbon brushes, power cord, tines, felt washers, hitch pins, blower fans, blower and vacuum tubes, vacuum bag and straps, guide bars, saw chains, hoses, connector fittings, spray nozzles, wheels, spray wands, inner reels, outer spools, cutting lines, spark plugs, air filters, gas filters, mulching blades, etc.
- 4. For servicing, the product must be sent or presented to a RYOBI authorized service station listed for each country in the following list of service station addresses. In some countries your local RYOBI dealer undertakes to send the product to the RYOBI service organisation. When sending a product to a RYOBI service station, the product should be safely packed without any dangerous contents such as petrol, marked with sender's address and accompanied by a short description of the fault.
- 5. A repair/replacement under this guarantee is free of charge. It does not constitute an extension or a new start of the guarantee period. Exchanged parts or tools become our property. In some countries delivery charges or postage will have to be paid by the sender.
- This guarantee is valid in the European Community, Switzerland, Iceland, Norway, Liechtenstein, Turkey and Russia.Outside these areas, please contact your authorized RYOBI dealer to determine if another warranty applies.
